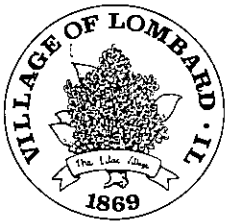

The FY 2006 budget includes replacement of ST334, a 2000 1 ton dump truck with plow. The bid results are as follows:

Vendor	Bid Price	Less Trade-In	Net Total Bid
Northwest Ford Franklin Park, IL	49,397	14,000	35,397
Oakfield Ford Villa Park, IL	49,960	14,500	35,460
Ron Tirapelli Ford Shorewood, IL	50,925	12,500	38,425

Public Works received three sealed bids. Northwest Ford was low bidder. The bid price for the 2006 1 ton dump truck with plow is \$49,397 less a trade-in allowance of \$14,000 equals a net total bid of \$35,397. The budgeted amount is \$36,000.

I recommend the award of a contract to Northwest Ford of Franklin Park, IL. in an amount not to exceed \$35,397. I also recommend declaring village unit number ST334 as surplus per the attached ordinance and authorizing its trade-in. Waiver of first reading is requested on this ordinance. Please submit this item to the Village Board for their consideration at the September 1, 2005 meeting.

**ORDINANCE AUTHORIZING THE SALE AND/OR DISPOSAL  
OF MUNICIPAL OWNED PERSONAL PROPERTY**

**WHEREAS**, in the opinion of the Corporate Authorities of the Village of Lombard, it is no longer necessary or useful to or in the best interest for the Village of Lombard to retain the following described personal property:
