SUBJECT: Cruise Nights/Temporary Parking Restrictions

The following parking restrictions are adopted each year in support of Cruise Nights. These restrictions limit parking along St. Charles Road between Main Street and Lincoln Avenue, and along Park Avenue between Orchard Terrace and Michael McGuire Drive on certain Saturday nights from the hours of 5:30 p.m. to 10:30 p.m. Given that the final dates of the events for Cruise Nights are yet to be determined, the restrictions shall apply on the dates that a Cruise Night event is formally scheduled.

RESOLUTION R -21

A RESOLUTION TEMPORARILY LIMITING PARKING ALONG ST. CHARLES ROAD BETWEEN MAIN STREET AND LINCOLN AVENUE AND ALONG PARK AVENUE BETWEEN ORCHARD TERRACE AND MICHAEL MCGUIRE DRIVE

WHEREAS, the Village of Lombard wishes to host and otherwise operate "Cruise Nights," on Saturday nights in the summer with final dates to be determined;

WHEREAS, it is necessary to limit parking along St. Charles Road between Main Street and Lincoln Avenue and along Park Avenue between Orchard Terrace and Michael McGuire Drive, during the various "Cruise Nights" as described above, to allow for the event to take place;

NOW, THEREFORE, Be It Resolved by the President and Board of Trustees of the Village of Lombard, Du Page County, Illinois, as follows:

SECTION 1: That the portion of St. Charles Road between Main Street and Lincoln Avenue, excluding those parking spaces restricting vehicle parking to 15 minutes, and along Park Avenue, between Orchard Terrace and Michael McGuire Drive, shall be closed to public parking on the following dates:

June: 12, 19, and 26 July: 10, 17, 24 and 31 August: 7, 14, 21 and 28

In the event that a "Cruise Night" does not occur on one or more of the aforementioned dates, the parking restriction, as set forth in this Section, shall not be applicable on said date(s).

SECTION 2: That the Village of Lombard, by and through its Cruise Nights volunteer staff members, shall determine at its sole discretion which vehicles participating in "Cruise Nights", if any, shall be allowed to park on the portion of St. Charles Road between Main Street and Lincoln Avenue, and on the portion of Park Avenue between Orchard Terrace and Michael McGuire Drive which is closed to public parking during the time periods designated herein.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval as provided by law.
