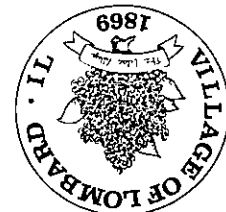

Subject: Transportation and Safety Recommendations

The Transportation and Safety Committee recommended the following items for Board action:

- **060622 - "No Parking," Jackson Street:** The Committee recommends posting "No Parking, Stopping, Standing" on the south side of Jackson Street from the intersection of Jackson Street and Addison Avenue to a point 80 feet west. This action will alleviate a significant sight-distance issue that occurs at this intersection, in particular when vehicles queue waiting to pick up children from Jackson Middle School.

- **060624 - "No Parking," Lincoln Avenue:** The Committee recommends posting "No Parking" along two areas of Lincoln Avenue to correct a sight-distance issue with vehicles exiting the Lincoln Park Condominium complex. The first will designate "No Parking" on the east side of Lincoln Avenue, from the curb of the northeast intersection of St. Charles Rd and Lincoln to a point 112 feet north. The second area will designate "No Parking" on the east side of Lincoln Avenue, from a point 502 feet from the northeast curb of the intersection of St. Charles Rd. and Lincoln Avenue to a point 547 feet from the same curb.

- **060625 - Traffic Code Update, St. Charles Road:** The Committee recommends updating the Village Traffic Code in order to bring St. Charles Road in-line with the Downtown Traffic Improvement Study recommendations, which have already been implemented.

Please present these items to the Board of Trustees at their regularly scheduled meeting on November 7, 2006 in accordance with the Committee's recommendations.

The following sections of the traffic code require an ordinance:

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

ORDINANCE NO. _____

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to
