

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 121,
SECTION 121.03A.(2) OF THE LOMBARD VILLAGE CODE IN
REGARD TO PUBLIC PASSENGER LICENSES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 121, Section 121.03A.(2) of the Lombard Village Code is amended to read as follows:

(2) Number

There shall be thirteen (13) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of granting a business license to FREETAXI.BIZ Dispatch, Inc. located at 1013 Eastern Avenue, Bellwood, Illinois.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
