22nd Street Shared-Use Path Design Engineering Contract

22nd Street Shared-Use Path Improvements is a new project included within the approved 2022-2031 Capital Improvement Program. The Village secured federal (STBGP) 2023 construction and construction observation funding for this project through the DuPage Mayors and Managers Conference. The 2023 construction project budget is \$1,080,000 (\$756,000 STBGP funds, \$324,000 Village funds), with Village budgeted funds of \$120,000 for 2022 design engineering/geotechnical services and \$120,000 (\$84,000 STBGP funds, \$36,000 Village funds) for 2023 construction observation/material testing services. The project is scheduled for design in 2022 and construction in 2023. The Village will create separate professional services contracts awarded in actual fiscal years.

This path improvement project will complete a missing path gap and rehabilitate the existing shared-use path from Finley Road to Meyers Road. The project includes a concrete multi-use path, pedestrian improvements, and lighting relocation. It is also included within the Village Bicycle and Pedestrian Master Plan and Village Bicycle/Pedestrian Network.

A Request for Proposal (RFP) was sent to all eligible firms on both 2021 Design and Resident Engineering Shortlists. Christopher B. Burke Engineering was determined by the Public Works selection evaluation team to be the most qualified firm. The contract scope and fee for design engineering and construction observation were negotiated and agreed to by both parties. Since this work will occur in separate fiscal years, this 2022 contract work will be performed for a total design engineering fee not to exceed \$139,603.65 from the CIP Engineering Fund.

Please present the attached agreement and resolution for the contract to the President and Board of Trustees for their review at their regular meeting of November 18, 2021. If approved, please return two original signed copies of the agreement to Public Works for further processing.
