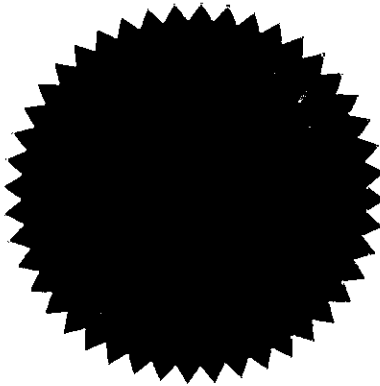

ORDINANCE 5041

**AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS**

(West Side of North Lombard Road)

WHEREAS, North Lombard Road right-of-way is an underimproved public right-of-way; and,

WHEREAS, the portion of said right-of-way, hereinafter described, is not within the corporate limits of any municipality, but is contiguous to the Village of Lombard; and,

WHEREAS, a request for annexation of all land within the territory hereinafter described, has been filed with the Village Clerk of the Village of Lombard, DuPage County, Illinois, pursuant to Chapter 65 ILCS 5/7-1-10; and,

WHEREAS, it is in the best interest of the Village of Lombard that said territory be annexed thereto.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: That the territory described in Section 2 below be and the same is hereby annexed to the Village of Lombard, DuPage County, Illinois, pursuant to Chapter 65 ILCS 5/7-1-10.

SECTION 2: This ordinance is limited and restricted to the property indicated on the attached Plat of Annexation attached hereto as Exhibit "A", and generally referenced as the western half of the North Lombard Road right-of-way north of the south line of the Commonwealth Edison right-of-way containing 0.9037 acres more or less and legally described as follows:

THAT PART OF THE WEST ½ OF THE LOMBARD AVENUE RIGHT OF WAY LYING SOUTH OF THE SOUTHERLY RIGHT OF WAY LINE OF THE ILLINOIS CENTRAL RAILROAD AND NORTH OF THE SOUTH RIGHT-OF-WAY LINE OF COMMONWEALTH EDISON COMPANY, IN THE

NORTHEAST ¼ OF SECTION 31, TOWNSHIP 40 NORTH, RANGE 11 EAST
OF THE THIRD PRINCIPAL MERIDIAN, IN DU PAGE COUNTY, ILLINOIS.

SECTION 3: The new boundary of the Village of Lombard shall extend to the far side of any adjacent rights-of-way, and shall include all of every right-of-way within the area annexed hereby.

SECTION 4: The Village Clerk is hereby directed to record with the Recorder of Deeds and to file with the County Clerk, a certified copy of this Ordinance, and the original Plat of Annexation.

SECTION 5: This ordinance shall be in full force and effect from and after its passage and approval as provided by law.




