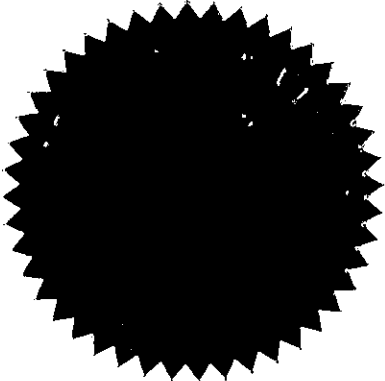

AN ORDINANCE AMENDING SCHEDULE VII OF THE LOMBARD TRAFFIC CODE (ORDINANCE NO. 1186) TO PROHIBIT PARKING ALONG NORTH AVENUE (ILLINOIS ROUTE 64), FROM A POINT TWENTY-FOUR (24) FEET EAST OF ILLINOIS ROUTE 53 EAST TO THE VILLAGE LIMITS

WHEREAS, the State of Illinois, acting by and through its Department of Transportation, is desirous of improving North Avenue (Illinois Route 64), from a point twenty-four (24) feet East of Illinois Route 53 to Addison Road, (hereinafter the "Improvement"); and

WHEREAS, a portion of the Improvement is located within the Village of Lombard (hereinafter the "Village"); said portion being from a point twenty-four (24) feet East of Illinois Route 53 East to Joyce Avenue (hereinafter the "Village Portion of the Improvement"); and


WHEREAS, in order to facilitate the free flow of traffic and ensure safety to the motoring public, the Village has determined that parking along North Avenue (Illinois Route 64) shall be prohibited within the limits of the Village Portion of the Improvement;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That pursuant to Article XIII, Section 10-13-1(b) of the Lombard Traffic Code, it shall be unlawful for anyone to park any vehicle along North Avenue (Illinois Route 64), from a point twenty-four (24) feet East of Illinois Route 53 East to Joyce Avenue, exclusive of the Frontage Roads constructed as part of the Village Portion of the Improvement. In accordance with the foregoing, Schedule VII of the Lombard Traffic Code (Ordinance No. 1186) is hereby amended by adding the following thereto:




