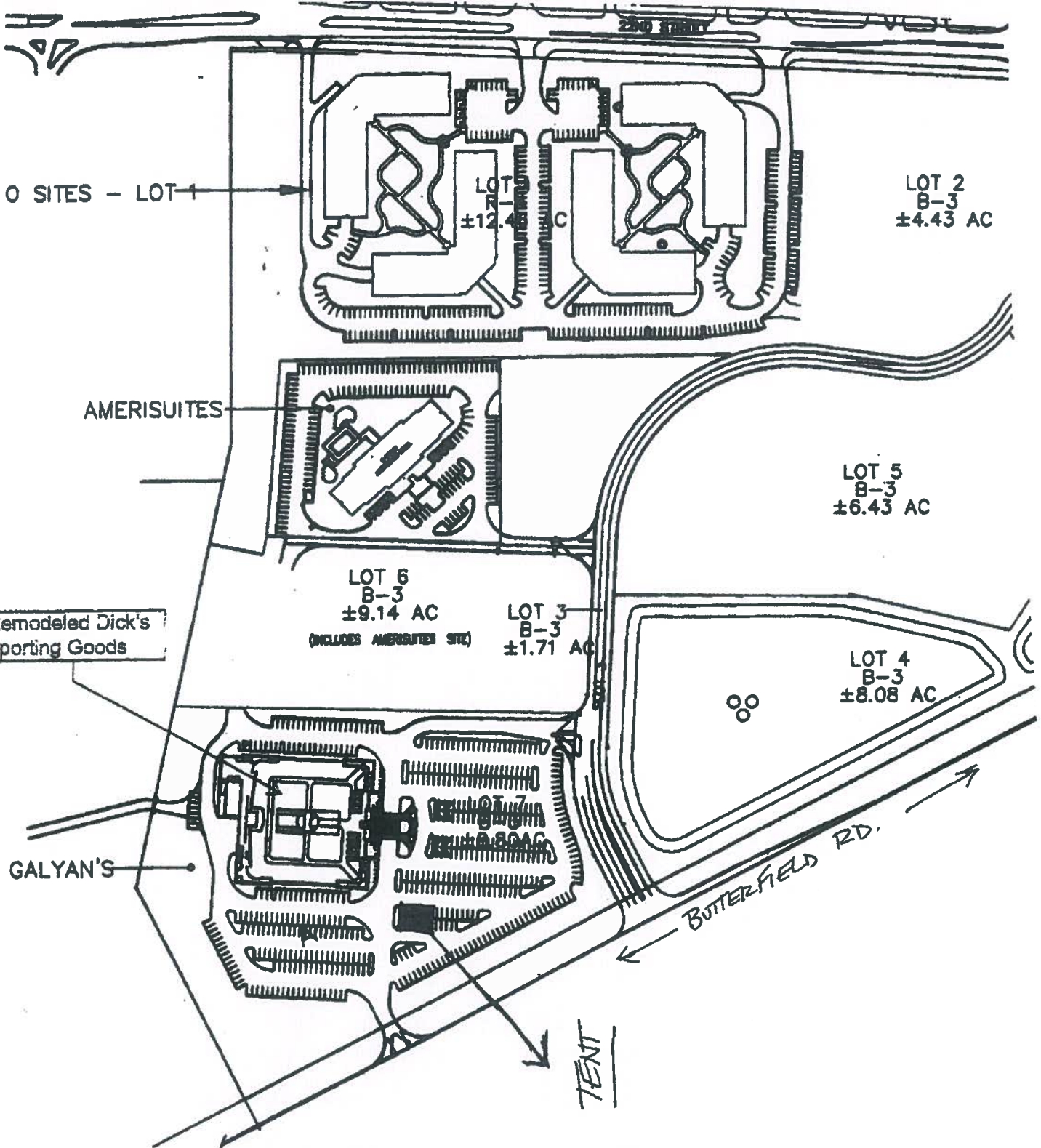
SUBJECT: Temporary Event – Dick’s Sporting Goods Tent Sale
