

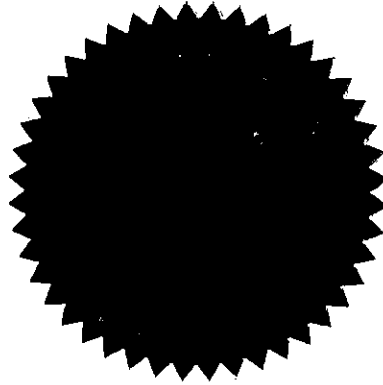

AN ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE
(ORDINANCE NO. 1186) IN RELATION TO THE USE OF
SKATEBOARDS, ROLLER SKATES, IN-LINE SKATES (ROLLER BLADES)
AND/OR SCOOTERS IN BUSINESS DISTRICTS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard,

DuPage County, Illinois, as follows:

SECTION 1: That the Lombard Traffic Code (Ordinance No. 1186) is hereby amended by

revising Article XIV, thereof by adding a new Section 10-14-21 thereto which shall read in its

entirety as follows:

"10-14-21. Skateboarding, Roller Skating, In-Line Skating (Roller
Blades) and Scooters in a Business District.

(a) No person shall ride a skateboard or scooter, or use roller skates
or in-line skates (roller blades), or use a similar device upon any
public right-of-way (including, but not limited to, a public street or
sidewalk or upon a public parking or loading area) within a Business
District as defined in Section 10-1-1 above, provided signs or
markings so prohibiting such activity are present;

(b) Any person found to be in violation of this Section shall be fined
not less than twenty-five and no/100 dollars (\$25.00) nor more than
seven hundred fifty and no/100 dollars (\$750.00)."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage

and approval as provided by law.






