Subject: Overhead Sewer Grant Funding Increase

Background

The Overhead Sewer Grant program has been funded in the Water/Sewer Capital Reserve Fund at \$50,000 per year. Historically the program has exhausted budgeted funds along with significant increases to the total budgeted amounts in FY2011 (\$187,435) and FY2013 (\$180,463). The increases in participation for these two years were directly related to the flooding and significant rain events during those years.

Participation continues to remain high in FY2014 due to the larger rain events this year and the continued concern from residents of future flooding. As of September 8, 2014; \$47,788.75 of the budgeted \$50,000 has been dispersed for reimbursements with an additional \$23,087.50 approved and pending final reimbursement. The pending grants are expected to be submitted for reimbursement in FY2014 along with the submission of potentially four to six new grant requests through the remainder of FY2014.

A formal request was made on July 30, 2014 to reallocate \$14,000 from the Backyard Drainage Grant (BYD) Program to the Overhead Sewer Grant Program to cover the then approved and pending submittal for reimbursement of \$12,000. An additional \$30,000 of funds is requested to be reallocated in accommodate the remainder of the approved and pending grants along with the potential new grant requests through FY 2014.

This program continues to provide a valuable service and resource to the residents of the Village of Lombard to help protect their homes from flooding.

Recommendations

I respectfully request that the Board of Trustees allocate an additional \$30,000.00 to this program to fulfill the pending and any additional reimbursement requests that are submitted through December 31, 2014.
