

BACKGROUND/POLICY IMPLICATIONS:

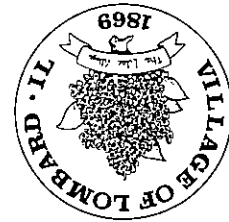

**MEMORANDUM**

**SUBJECT:** Resident-Only Commuter Parking

At its March 6, 2008 meeting, the Village Board converted 187 daily fee commuter parking spaces into Lombard resident-only permit spaces. In response to residents' requests for daily fee parking, staff proposes to turn 16 of the resident-only permit spaces in the 101 S. Main Street lot into resident-only daily fee spaces. As with the permit spaces, these daily fee spaces would be available to Lombard residents with current vehicle stickers.

**ACTION REQUESTED**  
Staff recommends that the Village Board approve the attached ordinance authorizing the conversion of 16 commuter parking spaces into Lombard resident-only daily fee parking.

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

ORDINANCE NO. \_\_\_\_\_

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

**Section 1:** That Article XIII, Section 10-13-18 of the Lombard Traffic Code is hereby amended to add a new subsection (d) which shall read in its entirety as follows:

“(d) Vehicles parked in those parking lots referenced in Schedule XII (d) shall be required to display a valid Village of Lombard vehicle sticker.”

**Section 2:** That Schedule XII (c) of the Lombard Traffic Code entitled LOMBARD RESIDENT PERMIT PARKING ZONES is hereby amended to read in its entirety as follows:

In accordance with Section 10-13-22, municipal parking permits may be issued authorizing the parking of private vehicles in the municipally owned or leased properties described as follows:

Vehicles parked in those parking lots referenced in Schedule XII (c) shall be required to display a valid Village of Lombard Municipal Resident Parking Permit between the hours of 5:00 a.m. and 3:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December. Parking permits shall be issued only to and valid only when displayed on vehicles displaying a valid Village of Lombard vehicle sticker.

**101 S. Main Street Lot (except those spaces designated as Lombard Resident Daily Fee Parking Zones in accordance with Schedule XII – (d)), Maple Street South Parking Lot and East Parkside Avenue Lot east of Charlotte Street –**

Quarterly Fee (3 month period) -	\$75.00 for residents
If less than 60 days, but more than 30 days, left in the Quarter -	\$50.00 for residents
If 30 days or less left in the Quarter -	\$25.00 for residents

**Section 3:** That Schedule XII (d) of the Lombard Traffic Code entitled LOMBARD RESIDENT DAILY FEE PARKING ZONES is hereby added to read in its entirety as follows:

In accordance with Section 10-13-14 and Section 10-13-18, Lombard resident daily fee parking zones are described below. The payment of fees in the coin box shall be required between the hours of 5:00 a.m. and 3:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December.

101 S. Main Street Lot: Six (6) spaces along the easternmost edge of the parking lot and ten (10) spaces along the northernmost edge of the parking lot

**Section 4:** That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs are provided by law.
