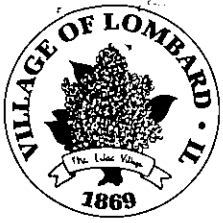

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B I" liquor license category, contained therein to read as follows:

Class "A/B I" – 10

SECTION 2: That the change in the number of Class "A/B I" liquor licenses set forth in Section 1 above, is a result of granting a liquor license to Taqueria No Way Jose, Inc. d/b/a Taqueria No Way Jose located at 621 E. Roosevelt Road, Lombard.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
