TITLE: Ordinance Providing for the Abatement of a Portion of the 2007 Property Tax Levy of the Village of Lombard Special Service Area #6

BACKGROUND/POLICY IMPLICATIONS:

On August 20, 1998, the Village Board approved Ordinance #4530 which provided for the issuance of \$385,000 in Special Service Area #6 Bonds for the Roosevelt Road Sidewalk Project. The property tax is levied only on property tax payers in the special service area. The ordinance, filed with the DuPage County Clerk, established a property tax levy schedule that the County Clerk must follow unless the Village Board approves an ordinance abating all or part of the annual levy.

The property tax levy for 2007 is \$52,325. The ordinance attached for your consideration abates a portion of the 2007 tax levy on this issue. I have determined that sufficient funds are available within the Special Service Area #6 fund to abate \$45,735 of the 2007 Special Service Area #6 property tax levy, which is the final year of this special service area tax levy.

In order to abate this levy, a certified copy of the attached ordinance must be filed with the DuPage County Clerk by March 31, 2008. Village Board consideration and approval of this recommendation is requested. In order to expedite the filing of the abatement ordinance, I am respectfully requesting waiver of first reading.

**AN ORDINANCE PROVIDING FOR THE ABATEMENT
OF A PORTION OF SPECIAL SERVICE AREA #6 TAX LEVY**

ORDINANCE NO. _____

WHEREAS, the Village of Lombard, a municipal corporation, has heretofore issued Special Service Area #6 Bonds dated August 20, 1998, in the amount of \$385,000; and

WHEREAS, the Village of Lombard has funds available for the purpose of retiring (a portion of the) principal and interest of the bonds aforesaid that was to be paid from the proceeds of the 2007 tax levy, said principal and interest totaling \$52,325.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS, as follows:

Section 1: That the tax levy to be extended for the year 2007 for the purpose of paying principal and interest of the Special Service Area #6 Bonds dated August 20, 1998, aforesaid, be and the same is reduced and abated in the amount of \$45,735.

Section 2: That a certified copy of this Ordinance be filed forthwith with the County Clerk of DuPage, Illinois.

Section 3: That this Ordinance shall be in full force and effect from and after its adoption and approval as provided by law.
