IV. Public Participation

Tom Masterson, 128 W. St. Charles Road, spoke about the grant for the Cabinet Depot store at 14 W. St. Charles. He noted the letter from the accountant indicated 83% wholesale and 17% retail sales. The Grant program calls for 25% retail to comply. He felt that sales tax was a poor justification for the retail grant to be awarded. He questioned awarding a retail grant to this business. He felt the Village had awarded a \$11,700 grant to a wholesale business which does not meet the standards of the retail grant program. He asked for reconsideration.

Lyn Magnavite, 69 N. Elizabeth, spoke about the retail grant for Cabinet Depot. She indicated she respected Mr. Masterson's comments and his thorough review of the documents, but felt it was encouraging a business to the downtown area and filling a vacant store. She felt the grant program should be reviewed.

Dan Whittington, 39 N. Elizabeth, Lombard Town Centre President, spoke about stores that had opened including the bridal shop, Shannon's Butcher Shop, a deli, the cabinet store, and a store selling new and used dance apparel. He indicated there were more meetings scheduled the following week and he hoped for additional businesses coming to downtown Lombard and vacancies being filled.
