SUBJECT: Amendment to Title 15, Chapter 150, Section 150.143

Contractor Registration and Insurance Requirements

Section 150.143 of the Building Code defines the term "contractor" as well as outlines the procedures and requirements involved with the contractor registration process. State statutes specifically exempt "fire alarm contractors" from having to register with a municipality as they are licensed by the State of Illinois, albeit the Village can still require that they submit their State license.

As a housekeeping issue, staff is requesting that our Code reflect this change and strike the words "fire alarm contractor" as outlined below:

§150.143 CONTRACTOR REGISTRATION AND INSURANCE REQUIREMENTS

For purposes of this subsection, a contractor is defined as any person or firm performing work as a general contractor, carpenter, electrician, communications contractor, plumber, sewer and water contractor, excavator, concrete contractor, roofer, heating ventilation and air conditioning (HVAC) contractor, masonry contractor, iron or steel contractor, lawn sprinkler contractor, fire sprinkler contractor, fire alarm contractor, paver and elevator contractor.

Please note that "fire sprinkler contractors" are still required to register with the Village.

Recommendation:

That the Village Board of Trustees recommend that Title 15, Chapter 150, Section 150.143 be amended to strike the words "fire alarm contractor". Staff recommends approval of this request with a waiver of first reading.

AN ORDINANCE GRANTING APPROVAL OF A TEXT AMENDMENT TO TITLE 15, CHAPTER 150, SECTION 150.143 OF THE LOMBARD VILLAGE CODE IN REGARD TO CONTRACTOR REGISTRATION AND INSURANCE REQUIREMENTS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 15, Chapter 150, Section 150.143 of the Village Code is hereby amended, in part, to strike "fire alarm contractor" from the list of defined contractors in order to comply with State Statute (225 ILCS 446/1 et. seq.).

§150.143 CONTRACTOR REGISTRATION AND INSURANCE REQUIREMENTS

For purposes of this subsection, a contractor is defined as any person or firm performing work as a general contractor, carpenter, electrician, communications contractor, plumber, sewer and water contractor, excavator, concrete contractor, roofer, heating ventilation and air conditioning (HVAC) contractor, masonry contractor, iron or steel contractor, lawn sprinkler contractor, fire sprinkler contractor, fire alarm contractor, paver and elevator contractor.

SECTION 2: That this ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
