## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor license, contained therein to read as follows:

Class "F" - 4

This decrease in Class "F" liquor licenses reflects the change in ownership of Famous Trading (Lombard) Inc. d/b/a Famous Liquors located at 105 E. Roosevelt Road, Lombard and the termination of the Class "F" liquor license issued to said licensee in relation thereto.

SECTION 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor license, contained therein to read as follows:

Class "F" - 5
