HOLD HARMLESS AND INDEMNIFICATION AGREEMENT RELATIVE TO THE CHICAGO BEARS TEMPORARY EVENTS AT 16 SOUTH PARK AVENUE, LOMBARD, ILLINOIS

In connection with any such claims, lawsuits, actions or liabilities, the Indemnified Parties shall have the right to defense counsel of their choice. The Business shall be solely liable for all costs of such defense and for all expenses, fees, judgments, settlements and all other costs arising out of such claims, lawsuits, actions or liabilities.
