SUBJECT: **Ordinance Amending Title 11, Chapter 112 – Alcoholic Beverages
Sections 112.24 and 112.30**

Attached are two ordinances amending Village Code Title 11, Chapter 112, relative to signage that a liquor licensee is required to post on their premises.

The first Ordinance amends Section 112.24 by adding a new subsection (D) mandating that a liquor licensee post a sign relative to birth defects and substance abuse assistance as required by and in compliance with State law 235 ILCS 5/6-24a(b).

The second Ordinance amends Section 112.30(B) relative to the “Warning to Minors” sign which includes:

- correcting the amount of a fine from “up to \$500” to “up to \$750”, which is consistent with other sections of Village Code;
- amending the language that the sign can be obtained from the “Village” rather than from the “Village Clerk”. This would allow the Police Department, who inspects each liquor licensee’s premise for compliance, and any other staff members to issue the sign if need be; and
- adding other non-substantive language for clarification

Staff has met with Village Counsel relative to these amendments who drafted the attached ordinances. Please place these items on the August 16, 2018 Village Board agenda for consideration.

**AN ORDINANCE
AMENDING TITLE XI, CHAPTER 112, SECTION 112.24
OF THE LOMBARD VILLAGE CODE
IN REGARD TO ALCOHOLIC BEVERAGES AND
BIRTH DEFECT AND SUBSTANCE ABUSE SIGNAGE**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.24 of the Lombard Village Code is amended by adding a new subsection (D) thereto, which shall read in its entirety as follows:

“(D) All licensees under this Chapter 112 shall post a sign, in plain view in the licensed premises, relative to alcoholic beverages and birth defects, and substance abuse assistance, as required by and in compliance with 235 ILCS 5/6-24a(b). Said sign may be obtained from the Village or the Illinois Liquor Control Commission.”

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.

ORDINANCE NO. _____

**AN ORDINANCE
AMENDING TITLE XI, CHAPTER 112, SECTION 112.30(B)
OF THE LOMBARD VILLAGE CODE IN REGARD TO
ALCOHOLIC BEVERAGES AND UNDERAGE SALE OR DELIVERY SIGNAGE**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.30(B) of the Lombard Village Code is amended to read in its entirety as follows:

“(B) All licensees under this Chapter 112 shall display at all times in a prominent place, in the licensed premises, in plain view, a printed sign, which may be obtained from the Village, and which shall read substantially as follows:

WARNING TO MINORS

(Persons Under 21 Years of Age)

You are subject to a fine of up to \$750 under the ordinances of the Village of Lombard if you purchase alcoholic liquor or misrepresent your age for the purpose of purchasing or obtaining alcoholic liquor.”

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
