**SUBJECT:** **Text Amendment to Title 11, Chapter 112, Section 112.13(A)**  
**“A/B” Liquor License Classification Changes**

Liquor license holders with a Class “A/B” license are required to report their annual gross dollars of alcoholic liquor sales yearly. The following liquor license holders require a change in their classification as follows:

- Chicago Tavern Group LLC d/b/a Marquette Kitchen & Tap, located at 18 W. St. Charles Road, reported an increase in their 2015 sales, which changes their classification from a Class “A/B-I” to a Class “A/B-II” liquor license
- JNJS Pizza Inc. d/b/a Roundheads Pizza, located at 275 W. Roosevelt Road, reported a decrease in their 2015 sales, which changes their classification from a Class “A/B-III” to a Class “A/B-II”

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That effective June 1, 2016, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-I" liquor license, contained therein, to read as follows:

Class "A/B-I" - 9

Section 2: That effective June 1, 2016, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license, contained therein, to read as follows:

Class "A/B II" - 11

Section 3: That effective June 1, 2016, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor license, contained therein, to read as follows:

Class "A/B III" - 14

Section 4: That the changes in the number of Class "A/B-I", "A/B-II" and "A/B-III" liquor licenses set forth in Sections 1, 2 and 3 are a result of Chicago Tavern Group LLC d/b/a Marquette Kitchen & Tap, located at 18 W. St. Charles Road, reporting an increase in their gross dollars of liquor sales in calendar year 2015, resulting in a change from a Class "A/B-I" to a Class "A/B-II" liquor license, and JNJS Pizza Inc. d/b/a Roundheads Pizza, located at 275 W. Roosevelt Road, reporting a decrease in their gross dollars of liquor sales in calendar year 2015, resulting in a change from a Class "A/B-III" to a Class "A/B-II".

Section 5: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
