Subject: November 2015 Meeting Item 1—Glenview Avenue Stop Sign and Speed Limit Reduction Request

The Police Department received a petition to install a Stop sign at Glenview/Eugenia and lower the Glenview speed limit to 25 mph. Twelve households are represented on the petition. Public Works and the Police Department discussed the street and related intersection. Per MUTCD Section 2B.04, Stop signs should not be used for speed control, and this intersection does not meet the required conditions for Stop signage. However, based on the below speeds, the street may be considered for a modified speed limit.

Street Direction	85% Percentile Speed
Northbound Glenview	26.47 mph
Southbound Glenview	25.94 mph

As shown in the attached petition, support exists for a speed limit modification, and the measured speeds are aligned with the speed limit request.

Staff recommends no signage change and recommends approving the speed limit modification request.
