SUBJECT: 309 W. St. Charles Road (Walgreens) - Plat of Abrogation of Utility

Easement

#### **BACKGROUND**

The proposed Walgreens property at 309 W. St. Charles Road currently has a utility easement running roughly through the center of the site. This easement was platted along the western edge of Lot 3 and the southwestern corner of Lot 1 in Marquardt's Resubdivision, which occurred in 1967. With the redevelopment of this property and consolidation of the lots, the existing easement would be within the proposed Walgreens building. Since buildings cannot be constructed across utility easements, the abrogation of that easement is now being requested.

No utilities presently exist in the easement and there will be no foreseeable need for the easement in the future. The Plat has already been signed by SBC, Nicor, Commonwealth Edison, and Comcast.

#### RECOMMENDATION

Staff recommends that the Village Board authorize the President and Village Clerk to sign the Plat of Vacation for the property at 309 W. St. Charles Road.
