ORDINANCE NO. 8005

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES AND THE EXISTING CLASS "E" AND NEW CLASS "E-VG" LIQUOR LICENSE CATEGORIES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by revising the language therein, relative to the Class "E" liquor license category, to read in its entirety as follows:

"Class "E" – Alcoholic beverages served as an adjunct to a sports and fitness center, or a recreational center not covered by a Class "M" or Class "R" liquor license, for consumption on the premises only, in a dedicated alcoholic beverages service area of no less than 1800 square feet in area; no package sales allowed. Food shall be available to patrons in the dedicated alcoholic beverages service area, whether from on-site food options or from delivery by off-site vendors; however, a full service kitchen shall not be required. Video gaming, as provided for under the Illinois Video Gaming Act, shall not be allowed on the licensed premises."

SECTION 2: That Title XI, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "E-VG" liquor license category, to read in its entirety as follows:

"Class "E-VG" – Alcoholic beverages served as an adjunct to a sports and fitness center, or a recreational center not covered by a Class "M" or Class "R" liquor license, for consumption on the premises only, in a dedicated alcoholic beverages service area of no less than 1800 square feet in area; no package sales allowed. Food shall be available to patrons in the dedicated alcoholic beverages service area, whether from on-site food options or from delivery by off-site vendors; however, a full service kitchen shall not be required. The operation of video gaming terminals on the licensed premises shall be allowed, so long as video gaming is not prohibited within the Village, provided the establishment has been issued a video gaming

license by the Illinois Gaming Board in accordance with the provisions of the Illinois Video Gaming Act, and further provided the establishment shall comply with all the provisions of Chapter 112 of the Village Code, the Illinois Video Gaming Act, and all rules, regulations and restrictions imposed by the Illinois Gaming Board."

SECTION 3: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein, relative to the Class "E" liquor license category, to read in its entirety as follows:

This decrease in the number of Class "E" liquor licenses reflects the termination of the Class "E" liquor license issued to Glass Court Club, Inc. d/b/a Glass Court Swim and Fitness, located at 830 East Roosevelt Road, Lombard, Illinois.

SECTION 4: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by adding language relative to a new Class "E-VG" liquor license thereto, which shall read in its entirety as follows:

This increase in the number of Class "E-VG" liquor licenses reflects the issuance of a new Class "E-VG" liquor license to Glass Court Club, Inc. d/b/a Glass Court Swim and Fitness, located at 830 East Roosevelt Road, Lombard, Illinois.

SECTION 5: That Title XI, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "E-VG" liquor license category, to read in its entirety as follows:

SECTION 6: That Title XI, Chapter 112, Section 112.40(A) of the Lombard Village Code is amended by revising the referenced therein to "A/B-II-VG, A/B-III-VG, A/B-IV-VG.

SECTION 7: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
