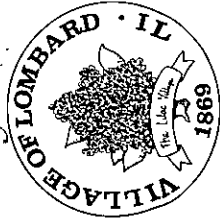

Subject: Sale of Surplus Ambulance

The FY 2008 budget includes replacement of FM62, a 2000 ALS ambulance. The BOT awarded the contract for a new ambulance to the low bidder, Midwest Emergency Vehicle of Kankakee, IL at the March 1, 2007 meeting. The surplus ambulance, Village unit number FM65 has since been marketed and sold to Apgar Ambulance of Laramie, WY for \$18,000. We have secured a \$1,800 deposit and consider this bidder to be responsible.

I recommend declaring Village unit number FM65 as surplus per the attached ordinance and authorizing its sale to Apgar Ambulance of Laramie, WY for \$18,000. Waiver of first reading is requested on this ordinance. Please submit this item to the Village Board for their consideration at the May 3, 2007 meeting.

ORDINANCE _____

ORDINANCE AUTHORIZING THE SALE AND/OR DISPOSAL
OF MUNICIPAL OWNED PERSONAL PROPERTY

WHEREAS, in the opinion of the Corporate Authorities of the Village of Lombard, it is no longer necessary or useful to or in the best interest for the Village of Lombard to retain the following described personal property:

FM65 2000 Ford F350 Ambulance VIN #1FDWFF34YED10331

now owned by the Village of Lombard; and

WHEREAS, The Village routinely declares such type of personal property surplus and the best interest of the Village of Lombard will be served by its sale and/or disposal.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS,
as follows:

Section 1: Pursuant to 65 ILCS 5/11-76-4, the President and Board of Trustees find the following described property:

FM65 2000 Ford F350 Ambulance VIN #1FDWFF34YED10331

now owned by the Village of Lombard is no longer necessary or useful to the Village of Lombard and the best interest of Lombard will be served by its sale/trade-in to Apgar Ambulance of Laramie, Wyoming in the amount of \$18,000.00.

Section 2: Pursuant to said 65 ILCS 5/11-76-4, the Village President and Clerk are hereby authorized and directed to sell and/or dispose of the aforementioned personal property now owned by the Village of Lombard.

Section 3: This ordinance shall be in full force and effect from and after its adoption and approval as provided by law.
