**SUBJECT:** **Amending Title XI, Chapter 112, Section 112.13(A) – Alcoholic Beverages  
Royal Liquors – 338 S. Main St.**

Jay Hari, Inc. d/b/a Royal Liquors located at 338 S. Main Street currently holds a Class “F” liquor license which allows the packaged sales of alcohol with the primary purpose of the establishment being a package store with no onsite consumption.

Staff has been advised that effective July 1, 2021, which is simultaneous to the new liquor licensing term, there will be a change of ownership. Village Code Title XI, Chapter 112, Section 112.20(D) states that a liquor license shall terminate whenever 50 percent or more of the ownership interest changes from that shown on the original license application. In that regard, Jay Hari, Inc. d/b/a Royal Liquors has made application for a new a new Class “F” liquor license. They indicate that no changes will be made in the day-to-day operations of Royal Liquors.

Attached is an ordinance decreasing and increasing the number of Class “F” licenses by one to reflect the ownership changes.

Staff is requesting a waiver of first reading in order to reflect these changes effective July 1, 2021.

**ORDINANCE \_\_\_\_\_**

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

**Section 1:** That, effective July 1, 2021, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor licenses, contained therein, to read as follows:

Class "F" - 4

This decrease in the number of Class "F" liquor licenses reflects the termination of the Class "F" liquor license issued to Jay Hari Inc. d/b/a Royal Liquors located at 338 S. Main St. due to a change of ownership effective July 1, 2021.

**Section 2:** That, effective July 1, 2021, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "F" liquor licenses, contained therein, to read as follows:

Class "F" - 5

This increase in the number of Class "F" liquor licenses reflects the issuance of a new Class "F" liquor license, effective July 1, 2021, to Jay Hari Inc. d/b/a Royal Liquors located at 338 S. Main Street, Lombard, IL.

**Section 3:** This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
