SUBJECT: **Text Amendment to Title 11, Chapter 112, Section 112.13(A)**
"A/B" Liquor License Classification Change

Liquor license holders with a Class "A/B" license are required to report their annual gross dollars of alcoholic liquor sales yearly. The following liquor license holder requires a change in its classification as follows:

- SBBL LLC d/b/a Brauerhouse, located at 1000 Rohlwing Road, reported an increase in their 2015 sales, which changes their classification from a Class "A/B-II" to a Class "A/B-III" liquor license

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That effective June 1, 2016, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license, contained therein, to read as follows:

Class "A/B-II" - 10

Section 2: That effective June 1, 2016, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor license, contained therein, to read as follows:

Class "A/B III" – 15

Section 3: That the changes in the number of Class "A/B-II" and "A/B-III" liquor licenses set forth in Sections 1 and 2 are a result of SBBL LLC d/b/a Brauerhouse, located at 1000 N. Rohlwing Road reporting an increase in their gross dollars of liquor sales in calendar year 2015, resulting in a change from a Class "A/B-II" to a Class "A/B-III" liquor license.

Section 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
