"A/B" Liquor License Classification Change

Liquor license holders with a Class "A/B" license are required to report their annual gross dollars of alcoholic liquor sales yearly. The following liquor license holder requires a change in its classification as follows:

• SBBL LLC d/b/a Brauerhouse, located at 1000 Rohlwing Road, reported an increase in their 2015 sales, which changes their classification from a Class "A/B-II" to a Class "A/B-III" liquor license

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That effective June 1, 2016, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license, contained therein, to read as follows:

Class "A/B-II" - 10

Section 2: That effective June 1, 2016, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor license, contained therein, to read as follows:

Class "A/B III" - 15

<u>Section 3</u>: That the changes in the number of Class "A/B-II" and "A/B-III" liquor licenses set forth in Sections 1 and 2 are a result of SBBL LLC d/b/a Brauerhouse, located at 1000 N. Rohlwing Road reporting an increase in their gross dollars of liquor sales in calendar year 2015, resulting in a change from a Class "A/B-II" to a Class "A/B-III" liquor license.

Section 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
