Number of Authorized Liquor Licenses

Casa Real of Lombard LLC d/b/a Casa Real Cosina Mexicana located at 569 E. Roosevelt Road currently holds an "A/B-II" liquor license. Staff was informed (and thereafter confirmed with the owner) that as of Monday, February 22, Casa Real Cosina Mexicana ceased operations. As a result, attached is an ordinance decreasing the Class "A/B-II" liquor license category by one as required by Village Code.

Staff is requesting a waiver of first reading in order to bring the number of licenses available in the "A/B-II" liquor classification current to reflect this change.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor licenses contained therein, to read as follows:

Class "A/B-II" - 9

Section 2: That the decrease in the number of Class "A/B-II" liquor licenses set forth in Section 1 above, is a result of Casa Real of Lombard LLC d/b/a Casa Real Cosina Mexicana no longer conducting business at 569 E. Roosevelt Road.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
