ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

Section 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding the following thereto:

“Class “L-II” – The sale of beer and wine only, by the glass, for consumption on the premises, in conjunction with the package sales of beer only. Beer tastings shall be allowed, with or without a charge therefor. A minimum seating capacity of fifty (50) seats is required. Food may be provided to the patrons, from restaurants that have entered into an agreement with the liquor licensee to deliver carry-out food to the licensed premises.”

Section 2: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by adding the following to the list of available licenses:

“Class “L-II – 1”

That the change in the number of L-II liquor licenses set forth in Section 1 above, is a result of granting a liquor license to The Beer Haus, LLC doing business as Beer House located at 322 Yorktown Center, Lombard.

Section 3: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding the following to the list of semi-annual license fees:

“Class “L-II” - \$1000.00”

Section 4: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by revising the reference therein to “Class “L,” to read “Class L-I,” and the holder of any existing Class “L” liquor license shall be issued a new Class “L-I” liquor license to replace the Class “L” liquor license.

Section 5: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the reference therein to “Class “L” -1” to read “Class L-I”- 1”.

Section 6: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by revising the reference therein to “Class “L” - \$750.00,” to read “Class L-I”- \$750.00”.

Section 7: That Title 11, Chapter 112, Section 112.40(A) of the Lombard Village Code is amended by revising the reference therein to "L," to read, "L-I, L-II."

Section 8: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
