## **ORDINANCE NO. 7147**

## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor license, contained therein, to read as follows:

Class "A/B-III" - 14

This decrease in the number of Class "A/B-III" liquor licenses reflects a change in ownership of Capital Grille of Lombard, located at 87 Yorktown, and the termination of the Class "A/B-III" liquor license issued to Rare Hospitality Management Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor license, contained therein, to read as follows:

Class "A/B-III" - 15

This increase in the number of Class "A/B-III" liquor licenses reflects the issuance of a new Class "A/B-III" liquor license to Capital Grille Holdings, Inc. d/b/a The Capital Grille #8026 located at 87 Yorktown, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
