

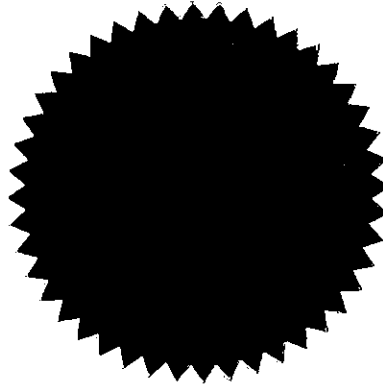

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule X (d) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS (for a period not to exceed two hours between the hours of 8:00 a.m. and 6:00 p.m. on any day except Sundays and holidays) be amended to add the following thereto:

Name of Street	From	To
Taylor Road, south side	west curb line of Charlotte Street	to a point 180 feet west of the west curb line of Main Street

Section 2: That Schedule X (d) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS (for a period not to exceed two hours between the hours of 8:00 a.m. and 6:00 p.m. on any day except Sundays and holidays) be amended to delete the following therefrom:

Name of Street	From	To
Taylor Road, south side	west curb line of Charlotte Street	40 feet east of Main Street

Section 3: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

Name of Street	From	To
Taylor Road, north side	east curb line of Fairfield Ave. east	end of street
Taylor Road, north side	220 feet west of the east curb line of Charlotte St.	east curb line of Lincoln Street

Section 4: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to delete the following therefrom:

Name of Street	From	To
Taylor Road, north side	Elizabeth Street	a point 204 feet east of east right-of-way line of Fairfield Ave.
Taylor Road, north side	Main Street	a point 220 feet east

Section 5: That Schedule VIII (m) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS (between the hours of 9:00 a.m. – 3:00 p.m. on school days) be amended to add the following thereto:

Name of Street	From	To
Taylor Road, north side	west curb line of Hammerschmidt Ave.	a point 200 feet west of the west curb line of Charlotte St.
Taylor Road, north side	west curb line of Lincoln St., west	end of street
Taylor Road, south side	180 feet west of the west curb line of Main Street, west	end of street
Taylor Road, south side	west curb line of Hammerschmidt Ave.	east curb line of Charlotte St.

Section 6: That Schedule VIII (m) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS (between the hours of 9:00 a.m. – 3:00 p.m. on school days) be amended to delete the following therefrom:

Name of Street	From	To
Taylor Road, north and south side	Main Street	Dead end

Section 7: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.






