

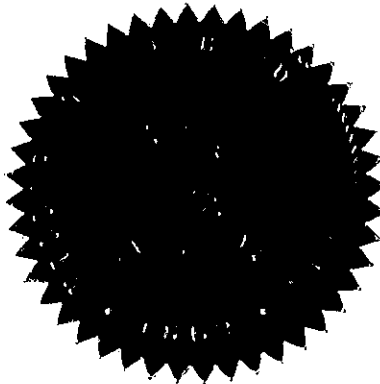

**ORDINANCE NO. 4677**

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VIII (m) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS between the hours of 9:00 a.m. to 3:00 p.m. on school days be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Ann Street South side	West curb line of Main Street	a point 155 feet west

Section 2: That Schedule XIV (f) of the Lombard Traffic Code (Ordinance 1186) entitled NO LEFT TURN between the hours of 8 a.m. to 4 p.m. on school days be amended to add the following thereto:

<u>Name of Street</u>	<u>Direction</u>	<u>At</u>
Madison School Driveway	Eastbound	Madison Street
West Green Valley Drive	Eastbound	Madison School Driveway
Madison School Driveway	Southbound	West Green Valley Drive
Elizabeth Street	Eastbound	Parkview School Driveway
Parkview School Driveway	Southbound	Elizabeth Street

Section 3: That Schedule XX (a) of the Lombard Traffic Code (Ordinance 1186) entitled NO STOPPING, STANDING OR PARKING be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Madison Street North side	East curb line of West Green Valley Dr.	a point 680 feet east

Section 4: That Schedule XX (a) of the Lombard Traffic Code (Ordinance 1186) entitled NO STOPPING, STANDING OR PARKING be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Madison Street North side	East curb line of West Green Valley Dr.	a point 285 feet east

Section 5: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
