**SUBJECT:** An Ordinance Amending the Lombard Village Code Regarding COVID-19

Attached is an ordinance which amends the Lombard Village Code relative to provisions pertaining to COVID-19. During the COVID-19 pandemic, multiple sections of the Lombard Village Code were amended with provisions specific or relating to COVID-19. Staff has worked with the Village Attorney to review these provisions, determined that these sections of the code are obsolete, and drafted an ordinance removing such provisions from the Village Code.

The sections of the Village Code proposed for removal cover a variety of areas including:

- Declaring violations of Executive Orders of the State of Illinois a public nuisance;
- Waiver of penalties fees for late payments;
- Automatic extension of certain business license renewals;
- Parking requirements reductions for temporary expansion of restaurant outdoor dining areas; and,
- Extension of construction and building permits

Several of the provisions above were applicable solely for specific time periods within 2020 and are currently obsolete. The remaining provisions are no longer applicable to current municipal or business operations post-pandemic.

**ORDINANCE NO.**

**AN ORDINANCE AMENDING THE LOMBARD VILLAGE CODE TO DELETE PROVISIONS RENDERED OBSOLETE BY THE END OF THE COVID-19 PANDEMIC**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title III, Chapter 36, Article I, Section 36.08 is hereby amended by deleting Section 36.08 in its entirety.

**SECTION 2:** That Title IX, Chapter 94, Article II, Section 94.26 is hereby amended by deleting Section 94.26 in its entirety.

**SECTION 3:** That Title XI, Chapter 116, Sections 116.07 and 116.08 are hereby amended by deleting Sections 116.07 and 116.08 in their entirety.

**SECTION 4:** That Title XI, Chapter 119, Article III, Section 119.22 is hereby amended by deleting Subsection (K) in its entirety.

**SECTION 5:** That Title XV, Chapter 150, Article XVII, Section 150.142 is hereby amended by deleting Subsection (J) in its entirety.

**SECTION 6:** All ordinances and parts of ordinances in conflict with or inconsistent with the provisions of this Ordinance are hereby repealed to the extent of any such conflict or inconsistency.

**SECTION 7:** That if any part or portion of this Ordinance shall be declared invalid by a court of competent jurisdiction, such invalidity shall not affect the remainder of this Ordinance.

**SECTION 8:** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
