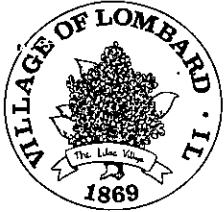

Subject: Recommendations from the Transportation and Safety Committee

At the August 8, 2005, Transportation and Safety Committee meeting, the committee recommended the following items:

- The intersection of Fairview Avenue at Morris Court to remain with no traffic control at this time.
- 16th Street west of Highland Avenue to remain with no parking restrictions at this time and to continue to monitor this area for parking problems.
- The intersection of Morris Avenue at Church Avenue to remain with no traffic control at this time and to install school advance warning signs on Morris Avenue in advance of the school speed limit signs and school crosswalk warning signs at the school crossing.
- Restrict parking on the north side of Washington Boulevard from the west curb line of Westmore-Meyers Road to a point 110 feet west.
- Change the "Yield" signs on Joyce Avenue at Berkshire Street to "Stop" signs.

The following sections of the traffic code require an ordinance:

Add: Schedule IV – Stop Streets

Joyce Avenue shall stop at Berkshire Street.

Delete: Schedule V – Preferential Streets

Joyce Avenue will yield to Berkshire Street.

Add: Schedule VII – parking Prohibited at all Times on Certain Streets

North side of Washington Boulevard from the west curb line of Westmore-Meyers Road to a point 110 feet west.

ORDINANCE NO. _____

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>Shall Stop At</u>	<u>Name of Street</u>
Joyce Avenue	“	Berkshire Street

Section 2: That Schedule V of the Lombard Traffic Code (Ordinance 1186) entitled PREFERENTIAL STREETS be amended to delete the following therefrom:

Joyce Avenue will yield to Berkshire Street

Section 3: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Washington Blvd North side	west curb line of Westmore/Meyers Road	a point 110 feet west

Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
