SUBJECT: Fleet Facility Expansion Project Architectural Services Contract Amendment

The Village Board of Trustees approved a contract with TRIA Architecture on May 5, 2022 in the amount of \$285,700.00 for the architectural services for the Fleet Facility Expansion Project. This contract included the design work and contract document preparation for the project; however, the scope of work and associated level of effort did not include any work related to the review of shop drawings, preparing responses to contractor requests for information (RFI) or inspection of the facility and preparation of the punch list post construction. It was anticipated that these items would be handled on an as-needed basis at an hourly rate.

The facility expansion has been completed and all work required of TRIA Architects has been performed. In accordance with the Village's financial policies, staff is recommending that the Village Board approve a contract amendment with TRIA Architects in the amount of \$50,380.70. The amendment will bring the total contract amount for the architectural services up to \$335,980.70.

Attached please find the amendment for the architectural services with TRIA Architecture in the amount of a net increase of \$50,380.70. The amendment includes all of the additional work effort to complete the Fleet Facility Expansion project. The detailed information regarding the amendment #1 can be found in the attachment.

Please place this contract amendment on the June 20, 2024 Village Board of Trustees agenda for their review and approval.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

**SECTION 1:** That after reviewing the explanation of staff as to the necessity of and reasons for the Amendment attached hereto as Exhibit "A", the President and Board of Trustees find as follows:

- A That the circumstances which necessitated said Amendment were not reasonably foreseeable at the time the contract was entered into.
- B. That the basis of the Amendment was not within the contemplation of the contract when the contract was signed.
- C. That it is in the best interests of the Village of Lombard to approve the Amendment in its proposed form.
- D. That to the extent that it may have been necessary to go to bid relative to the work contemplated by said Amendment, bidding is hereby specifically waived as to the Amendment work.

SECTION 2: That having made the findings set forth in Section 1 above, the President and Board of Trustees hereby approve the Amendment attached hereto as Exhibit "A", and direct and authorize the Village President and Village Clerk to execute said Amendment on behalf of the Village.
