

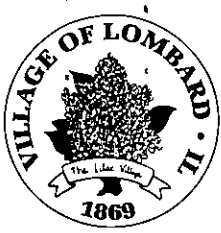

**ORDINANCE \_\_\_\_\_**  
**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,**  
**SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN**  
**REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES**  
**OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B IIP" liquor license, contained therein, to read as follows, effective May 15, 2011

Class "A/B III" - 16

This increase in Class "A/B IIP" liquor licenses reflects the issuance of a Class "A/B IIP" liquor license to DMK Burger Bar II LLC, located at 2370 S. Fountain Square Drive, Lombard, who will be operating the business commonly known as DMK Burger Bar.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
