AN ORDINANCE AMENDING TITLE III, CHAPTER 34 OF THE LOMBARD VILLAGE CODE IN REGARD TO CHILD PASSENGER SAFETY INSTRUCTIONAL COURSES PROVIDED BY THE LOMBARD POLICE DEPARTMENT

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title III, Chapter 34 of the Lombard Village Code is amended by adding a new Section 34.08 thereto, which shall read in its entirety as follows:

"§34.08 Child Passenger Safety Instructional Courses.
The cost for participation in a Child Passenger Safety Instructional Course, as referenced in 625 ILCS 25/6a, (the "Safety Course"), which is conducted by a member of the Lombard Police Department who is a "technician," as defined by 625 ILCS 25/6a(a), shall be Forty and No/100 Dollars (\$40.00). Said amount shall be paid by each individual participating in the Safety Course prior to the beginning of the Safety Course."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.


