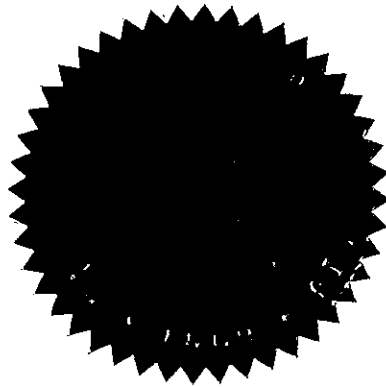

ORDINANCE 4959

**ORDINANCE AUTHORIZING THE SALE AND/OR DISPOSAL OF  
MUNICIPAL OWNED PROPERTY**

**WHEREAS**, in the opinion of the Corporate Authorities of the Village of Lombard, it is no longer necessary or useful to or in the best interest for the Village of Lombard to retain the following described property, now owned by the Village of Lombard; and

**WHEREAS**, The Village routinely declares such unused items as surplus and the best interest of the Village of Lombard will be served by its sale and/or disposal.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS**, as follows:

Section 1: Pursuant to 65 ILCS 5/11-76-4, the President and Board of Trustees find the following described property:

1995 Wells Cargo Trailer, Model #TW142, Serial #1WC200F25S1070122

now owned by the Village of Lombard is no longer necessary or useful and has no resale value to the Village of Lombard. Therefore, it is in the best interest of the Village of Lombard to transfer title to the Lombard Park District.

Section 2: Pursuant to said 65 ILCS 5/11-76-4, the Village President and Clerk are hereby authorized and directed to transfer title of the aforementioned Village property now owned by the Village of Lombard to the Lombard Park District and execute all documents necessary to consummate such conveyance.

Section 3: This ordinance shall be in full force and effect from and after its adoption and approval as provided by law.


