Number of Authorized Liquor Licenses**

Deli Capone Inc. d/b/a Capone's Restaurant & Pizzeria located at 105 W. St. Charles Road currently holds an A/B-I liquor license. At the close of business on May 31, 2015 Capone's Restaurant & Pizzeria ceased operations and concurrently their current liquor license expired. As a result, attached is an ordinance decreasing the Class A/B-I liquor license category by one as required by Village Code.

Staff is requesting a waiver of first reading in order to bring the number of licenses available in the A/B-I liquor classification current to reflect this change.

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-I" liquor licenses contained therein, to read as follows:

Class "A/B-I" - 9

Section 2: That the decrease in the number of Class "A/B-I" liquor licenses set forth in Section 1 above, is a result of Deli Capone Inc. d/b/a Capone's Restaurant & Pizzeria no longer conducting business at 105 W. St. Charles Road.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
