BACKGROUND/POLICY IMPLICATIONS:

Attached for your consideration are two ordinances amending Title 11 relative to providing outdoor viewing events in the event the Chicago Blackhawks play in the Stanley Cup Finals in June, 2013.

The first ordinance provides for the sale and consumption of alcohol in connection with up to seven temporary events at 11 and 16 S. Park Avenue. The second ordinance provides that a single permit be covering the entire event.

Staff is requesting a waiver of first reading due to time constraints.

**SUBJECT:** **Special Event Liquor Licenses for Punky's Pub and Shannon's Deli for the 2013 Stanley Cup Finals**

Given the possibility of the Chicago Blackhawks playing in the National Hockey League (NHL) Stanley Cup Finals, two ordinances have been drafted to allow for outdoor viewing of selected games that could provide for the sale and consumption of alcoholic beverages with the viewing event. Should the Blackhawks advance to the Stanley Cup, the event would be similar in design and operations as the viewing event for the Bowl Championship Series (BCS) previously held in the downtown on January 7, 2013. Unlike the BCS game, the dates, times and participants for the Stanley Cup Finals have not been set. However, as the Village Board will not meet again until June 20, staff is bringing this item forward for consideration at this time.

Attached are two ordinances to allow for outdoor viewing event(s) to be held in the month of June 2013, but only in the event that the Chicago Blackhawks hockey team is playing in the Stanley Cup Finals:

1. AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.18(B) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES, PROVIDING FOR THE SALE AND CONSUMPTION OF ALCOHOL IN CONNECTION WITH UP TO SEVEN (7) TEMPORARY EVENTS AT 11 AND 16 SOUTH PARK AVENUE
2. AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.47(B) OF THE LOMBARD VILLAGE CODE IN REGARD TO TEMPORARY EVENTS

Should the aforementioned Ordinances be approved, staff will work with the relevant parties (i.e., Punky's, Shannon's and Lombard Town Centre), to finalize the plans for any such viewing events. Issues to be finalized include the number of desired viewing events, specific dates and times (usually 7:00 p.m. game start times), event conflicts, labor/staffing, equipment availability, and outdoor space availability.

**ACTION REQUESTED**

This item is being placed on the June 6, 2013 Village Board consideration for consideration and approval. Staff recommends waiver of first reading.

In regard to the attached documents, please note the following:

1. The special Class "J" liquor licenses can only be issued if the Blackhawks make it to the 2013 Stanley Cup Finals.
2. The service of alcoholic liquor pursuant to the special Class "J" liquor licenses begins two (2) hours before game time, and ends thirty (30) minutes after the end of each game.
3. The Hold Harmless and Indemnification Agreements should be executed as part of the Liquor License and Temporary Event Permit application processes.

**ORDINANCE NO. \_\_\_\_\_**

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.18(B)  
OF THE LOMBARD VILLAGE CODE IN REGARD TO  
ALCOHOLIC BEVERAGES, PROVIDING FOR THE SALE AND CONSUMPTION  
OF ALCOHOL IN CONNECTION WITH UP TO SEVEN (7)  
TEMPORARY EVENTS AT 11 AND 16 SOUTH PARK AVENUE**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 112, Section 112.18(B) of the Lombard Village Code is amended by adding a new subsection (6) thereto, effective upon the adoption of this Ordinance through 11:59 p.m. on Sunday, June 30, 2013, which shall read in its entirety as follows:

“(6) In light of the fact that Bill and Punky’s Step Up Inn, Ltd. d/b/a Punky’s Pub, located at 16 South Park Avenue, and Shannons on Park, Inc. d/b/a Shannon’s Deli, located at 11 South Park Avenue, are holding up to seven (7) temporary events for the viewing of the 2013 Stanley Cup Finals, but only in the event that the Chicago Blackhawks hockey team is playing in the Stanley Cup Finals, said liquor licensees shall each be eligible for a Class “J” liquor license, despite the fact that said liquor licensees are for-profit business entities, for the sole purpose of selling alcoholic beverages for consumption in a designated and secured area adjacent to each of said licensed premises, to be approved by the Village pursuant to the issuance of a temporary event permit under Chapter 110 of the Village Code, beginning two (2) hours prior to the start of each Stanley Cup Finals hockey game in which the Chicago Blackhawks hockey team is playing, and terminating thirty (30) minutes after the conclusion of each Stanley Cup Finals hockey game in which the Chicago Blackhawks hockey team is playing. The liquor licenses to be issued under this subsection (6) may be issued by the Local Liquor Commissioner upon proper application to the Village, and satisfaction of all applicable requirements and conditions by the licensees. No liquor license shall be issued under this subsection (6) until such time as each licensee obtains the necessary temporary event permit under Chapter 110 of the Village Code and complies with all requirements and conditions thereof, including, without limitation, the insurance, bond and indemnification requirements of Chapter 110 for temporary events.”

**SECTION 2:** That, effective at 11:59 p.m. on Sunday, June 30, 2013, Title 11, Chapter 112, Section 112.18(B)(6) of the Lombard Village Code, as set forth in Section 1 above, is hereby repealed, without need for any further action by the President and Board of Trustees.

**SECTION 3:** That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.47(B)  
OF THE LOMBARD VILLAGE CODE IN REGARD TO TEMPORARY EVENTS**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 110, Section 110.47(B) of the Lombard Village Code is amended by adding the following language to the end thereof:

“In the case of an entity which holds a Class “J” liquor license, pursuant to Section 112.18(B)(6) of this Code, a single permit shall be issued covering the entire 2013 Stanley Cup Finals, relative to the events held in conjunction with said Class “J” liquor license during said 2013 Stanley Cup Finals.”

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
