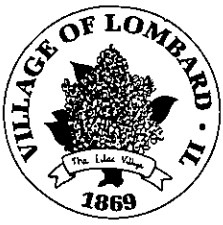
BACKGROUND/POLICY IMPLICATIONS:

I have received notification that Nagano Sushi Inc. d/b/a Nagano Japanese Restaurant located at 1005 E. St. Charles Road is in the process of selling their restaurant to Sakura Sushi, Inc. who will be doing business as Sakura Sushi.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "U" liquor license, contained therein to read as follows:

Class "U" - 2

This decrease in Class "U" liquor licenses reflects the change in ownership of Nagano Sushi Inc. d/b/a Nagano Japanese Restaurant located at 1005 E. St. Charles Road, Lombard and the termination of the Class "U" liquor license issued to said licensee in relation thereto.

SECTION 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B I" liquor license, contained therein to read as follows:

Class "A/B I" - 8

This increase in Class "A/B I" liquor licenses reflects the issuance of Class "A/B I" liquor license to Sakura Sushi, Inc. doing business as Sakura Sushi located at 1005 E. St. Charles Road, Lombard.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
