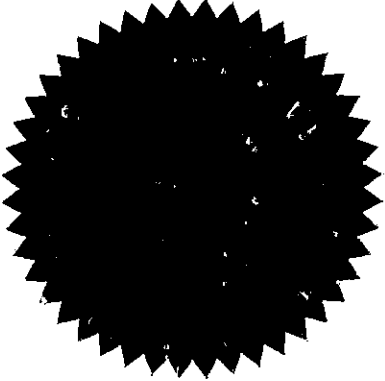

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1. That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STREETS be amended to add the following thereto:

Name of Street	Shall Stop At	Name of Street
Progress Rd., westbound	"	Main Street

Section 2. That Schedule V of the Lombard Traffic Code (Ordinance 1186) entitled PREFERENTIAL STREETS be amended to delete the following therefrom:

Progress Road will yield to Main Street

Section 3. That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

Name of Street	From	To
15 <sup>th</sup> Street, south side	east curb line of Main Street	a point 85 feet east

Section 4. That Schedule VIII (m) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS (between the hours of 9:00a.m.-3:00p.m. on school days) be amended to add the following thereto:

Name of Street	From	To
Hammerschmidt Ave. East & west side	south curb line of Wilson Avenue	north curb line of Central Avenue
Morris Avenue, North side	west curb line of Main Street	dead end

Section 5: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.


