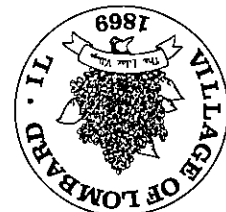

Subject: FY10 State Bid Vehicle Purchase

Included in the FY 2010 budget are the replacements for four marked squad cars. State bid for this type of vehicle has been awarded to Landmark Ford (contract # 4015559) of Springfield (IL). The cost of each unit is \$21,828 or \$87,312 for all four. Budgeted amount for this purchase is \$21,000 each or \$84,000 for all four. The shortfall will be re-cooped by the sale of the four squad cars that will be auctioned.
