601 E Butterfield Road

Village staff has been notified that more than fifty percent (50%) of the ownership interest of T.G.I. Friday's Inc. d/b/a T.G.I. Friday's located at 601 E. Butterfield Road, has changed pursuant to an asset purchase by Central Florida Restaurants, Inc. (CFR). CFR and the current liquor Licensee (T.G.I. Friday's Inc.) are operating under an Interim Management Agreement until all local and state licenses can be secured. CFR plans to operate the existing restaurant with the same concept, floor plans and staff.

Village Code requires that a liquor license shall terminate whenever fifty percent (50%) or more of the ownership interest changes from the original license application. Attached is an ordinance decreasing and increasing the Class "A/B-III" category by one to reflect the new ownership interest.

Staff is requesting a waiver of first reading in order to accommodate the new ownership in securing their local license in a timely fashion due to the Village Board's summer schedule.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class A/B-III" liquor license, contained therein, to read as follows:

Class "A/B-III" - 14

This decrease in Class "A/B-III" liquor license reflects a change in ownership of T.G.I. Friday's #0063, located at 601 E. Butterfield Road, and the termination of the Class "A/B-III" liquor license issued to T.G.I. Friday's Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor license, contained therein, to read as follows:

Class "A/B-III" - 15

This increase in Class "A/B-III" liquor licenses reflects the issuance of a Class "A/B-III" liquor license to Central Florida Restaurants, Inc. who is operating the business commonly known as T.G.I. Friday's located at 601 E. Butterfield Road, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
