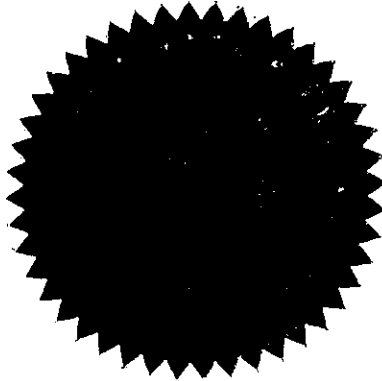

**AN ORDINANCE AMENDING TITLE 3, CHAPTER 30 OF THE  
LOMBARD VILLAGE CODE IN REGARD TO VILLAGE BOARD MEETINGS**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 3, Chapter 30, Section 30.01 of the Lombard Village Code is amended by revising the first sentence thereof to read as follows:

"Regular meetings of the Board of Trustees shall be held on the first, second and third Thursday of each month at 7:30 p.m. in the Board Room of the Village Hall."

**SECTION 2:** That Title 3, Chapter 30, Section 30.02(A) of the Lombard Village Code is amended by revising the reference therein to "24 hours" to read "48 hours."

**SECTION 3:** That the Village Clerk is hereby directed to advise all media, that have requested notice of the time and place of Village meetings, of this Ordinance. In addition, pursuant to 5 ILCS 120/2.03, the Village Clerk is directed to publish a notice of the additional meeting date set forth in Section 1 in a local newspaper. Said notice shall be in the form attached hereto as Exhibit "A" and made part hereof.

**SECTION 4:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
