**Ordinance to Modify a Left Turn Restriction at New Street and Hammerschmidt Avenue**

The Transportation and Safety Committee voted to endorse an Ordinance that would revise the time when a left turn is prohibited on westbound New Street to southbound Hammerschmidt Avenue from between 8 am to 4 pm, to between 8 am and 9 am, and between 3 pm and 4 pm.

**130140; Recommendation to Modify a Left Turn Restriction at New Street and Hammerschmidt Avenue**

Currently, a left turn at Hammerschmidt Avenue for westbound traffic on New Street is restricted on school days from 8 am to 4 pm, which coincides with the No Parking and One Way signage around Hammerschmidt School. On April 1, 2013, the Transportation and Safety Committee considered a request to modify the restriction times to when traffic is heaviest in the morning and afternoon only. Prior to making any recommendations, the Transportation and Safety Committee requested additional information from the Principal of Hammerschmidt School and the Lombard Police Traffic Unit, and subsequently voted to table this item. Public Works staff met with these representatives on site at 2:30 pm on April 19, 2013 and was informed there were no objections to the left turn modification request and restricting the left turn movement on school days between 8 am to 9 am and 3 pm to 4 pm would be acceptable.

During the May 13, 2013 meeting, the Transportation and Safety Committee voted to recommend the following modification to the Traffic Code:

**SCHEDULE XIV – NO LEFT TURN**

(e) In accordance with Village of Lombard Ordinances, left turns are prohibited at the following locations:

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule XIV of the Lombard Traffic Code (Ordinance 1186) entitled NO LEFT TURN, section (e), is amended to delete the following hereto:

“New Street, westbound, at Hammerschmidt Ave.”

Section 2: That Schedule XIV of the Lombard Traffic Code (Ordinance 1186) entitled NO LEFT TURN, is amended to add the following hereto:

“(k) In accordance with Ordinance 3240, left turns are prohibited between the hours of 8:00 am and 9:00 am; and between 3:00 pm and 4:00 pm on school days at the following locations.

Section 3: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
