## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

# BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: Effective March 1, 2016, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class "K" liquor license, contained therein, to read as follows:

"Class K" - 1

This decrease in "Class K" liquor license reflects the sale of King's Hall located at 1000 N. Rohlwing Road, Unit 40, and the termination of the "Class K" liquor license issued to King's Hall Corporation in relation thereto.

Section 2: Effective March 1, 2016, Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class K" liquor license, contained therein, to read as follows:

"Class K" - 2

This increase in "Class K" liquor licenses reflects the issuance of a "Class K" liquor license to Kings Hall II Inc. who is operating the business commonly known as King's Hall located at 1000 N. Rohlwing Rd., Unit 40, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
