NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: That the President and Board of Trustees of the Village of Lombard do hereby elect to include as earnings reportable to IMRF compensation directed into a Retirement Health Savings Plan effective January 1, 2005.

**SECTION 2:** That the Deputy Village Clerk is authorized and directed to file a duly certified copy of this resolution with the Illinois Municipal Retirement Fund.
