Subject: Coarse Aggregate Material – Waiver of Bids

Background

The Public Works Department uses Coarse Aggregate Material for trench backfill and pavement restorations throughout the Village after excavations and street repairs. The Village solicited bids for such material and delivery to the Surges Center and Public Works Yard located at 282 E Central Ave on an add-needed basis.

On Friday, February 9, 2018 bids were opened for the purchase of Coarse Aggregate Materials. Bid specifications were sent to nine vendors. Three bids were submitted and all met Village specifications.

The budgeted amount for FY 2019 is \$44,500.00 with unding as follows: Street Maintenance and Reconstruction (\$4,500), Water & Sewer Capital Reserve Fund Water Maintenance & Improvements RM PROG 32 (\$30,000) and Water & Sewer Capital Reserve Fund Sewer Maintenance & Improvements RM PROG 10 (\$10,000).

The Village of Lombard's current Coarse Aggregae Material Contract is set to expire December 31, 2018. We have valued the level of service and commitment from Vulcan Materials Co. has provided the Village of Lombard over the past year.

The Village exercised the option of extending the contract for an additional year for FY 2019 under the original contract terms and conditions as specified in contract PWO-1802. Vulcan Materials Co. has agreed to hold the original contract pricing for one more additional year from January 1, 2019 through December 31, 2019.

Recommendation

I recommend the Board of Trustees waive the bidding process and award a contract in an amount not to exceed \$44,500.00 for FY2019 for Course Aggregate Material to Vulcan Materials Co. of Naperville, IL. Please submit this recommendation to the Board of Trustees for their approval at the January 3, 2019 meeting.
