## AN ORDINANCE AMENDING TITLE 9, CHAPTER 91, SECTION 91.21 OF THE LOMBARD VILLAGE CODE IN REGARD TO FEES FOR EMERGENCY MEDICAL SERVICES

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 9, Chapter 91, Section 91.21 of the Lombard Village Code is amended as follows:

- A. Subsection (A) thereof is amended by deleting the column entitled, "Glenbard Fire Protection District Resident," from the chart contained therein, and relabeling the column entitled, "Non-Village/Non-Glenbard Fire Protection District Resident," to read, "Glenbard Fire Protection District Resident or Non-Village Resident."
- **B.** Subsection (G) thereof is hereby repealed.
- C. Subsections (H) and (I) thereof are revised by labeling said subsections as (G) and (H), respectively.

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as provided by law.
