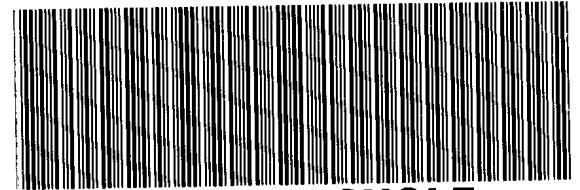

ORDINANCE 6252

**AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS**

(BOT 08-02: 18W665 13th Street)

(See also Ordinance No.(s) 6251)

WHEREAS, a written petition, signed by the legal owners and electors of record of all land within the territory hereinafter described, has been filed with the Village Clerk of the Village of Lombard, DuPage County, Illinois, requesting that said territory be annexed to the Village of Lombard; and,

WHEREAS, the said territory is not within the corporate limits of any municipality, but is contiguous to the Village of Lombard; and,

WHEREAS, all notices of said annexation, as required by (Chapter 65 ILCS 5/7-1-1), have been given to the appropriate parties in a timely manner as required by Statute (copies of said Notices being attached hereto as Exhibit "A", and made part hereof).

WHEREAS, it is in the best interest of the Village of Lombard that said territory be annexed thereto.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: That the territory described in Section 2 below be and the same is hereby annexed to the Village of Lombard, DuPage County, Illinois, pursuant to (Chapter 65 ILCS 5/7-1-8).

SECTION 2: This ordinance is limited and restricted to the property indicated on the attached Plat of Annexation attached hereto as Exhibit "B", and generally located at 18W665 13th Street, Lombard, Illinois and legally described as follows:

Lot 7 in Block 4 and the School Street right of way lying east of and adjacent to said Lot 7, in West York Center Community Co-Operative, Inc. Subdivision, being a subdivision in part of the North 60 acres of the East half of the Northeast Quarter of Section 20, and part of the West 30 acres of the Northwest Quarter of the Northwest Quarter of Section 21, all in Township 39 North, Range 11 East of the Third Principal Meridian, according to the plat thereof recorded April 19, 1947 as Document No. 521197, and also the 13th Street right of way lying Northerly of and adjacent to said Lot 7 and westerly of a line drawn from the Southwest Corner of Lot 6 in Block 2 in West York Center Community Cooperative, Inc. Subdivision aforesaid perpendicular to the South line of the 13th Street right of way and easterly of a line drawn from the Northwest corner of Lot 7 aforesaid to the angle point of the center line of said 13th Street, to a point on the Northerly line of the 13th Street right of way, said point being 8.76 feet Southwesterly of the Southwest corner of Lot 6 aforesaid, all in DuPage County, Illinois

SECTION 3: The new boundary of the Village of Lombard shall extend to the far side of any adjacent rights-of-way, and shall include all of every right-of-way within the area annexed hereby.

SECTION 4: The Village Clerk is hereby directed to record with the Recorder of Deeds and to file with the County Clerk, a certified copy of this Ordinance, and the original Plat of Annexation.

SECTION 5: This ordinance shall be in full force and effect from and after its passage and approval as provided by law.
